**CALL TO ORDER**

Mayor Johnson called the January 13, 2022 City Council regular meeting to order at 7:00 p.m.

**FLAG SALUTE**

Mayor Johnson led the Pledge of Allegiance.

**ADOPTION OF AGENDA**

**Councilmember French moved** to approve the agenda presented. **Deputy Mayor Kassover seconded. The motion to approve the agenda as presented carried unanimously.**

**COUNCIL ORGANIZATIONAL MEETING**

- **Adopt City Council Governance Manual**

Councilmember French moved to adopt the Governance Manual. **Bodi seconded. The motion to approve the Governance Manual as presented carried unanimously.**

- **Election of Deputy Mayor and Vice Chair**

Deputy Mayor Kassover called for nominations for Deputy Mayor. Deputy Mayor nominated Councilmember French as Deputy Mayor.

Deputy Mayor Kassover moved to appoint Councilmember French as Deputy Mayor. **Furutani seconded. The motion to appoint Councilmember French as Deputy Mayor carried unanimously.**

Councilmember Kassover turned over the meeting to Deputy Mayor French.

- **Appointment of Committee Chairs**

Deputy Mayor moved to appointed Councilmember Kassover as Vice-Chair. The motion was seconded by Councilmember Goldman.

Councilmember Riddle nominated herself as Vice-Chair.

City Administrator Hill presented the item and responded to questions from the Council.


