Mayor's Message: *Important Year for Lake Forest Park*

One constant in this newsletter for the past three years has been status updates on two key projects for Lake Forest Park – Lyon Creek Flood Mitigation and NE 178th Street Improvements. Both projects are out to bid at this time and we hope that, with good bid results, the year of construction has arrived. Also, as a part of the Lyon Creek project, we will see completion of the second phase of Whispering Willow Park.

This provides us a good point in time to look at these projects from a citizen's perspective. The periodic flooding of Lyon Creek is a short-term, but critical, event for many houses in the Sheridan Beach neighborhood and Town Center properties. Much of that area is listed as a flood zone on the Federal Emergency Management Agency (FEMA) flood maps. The project design will retain a 100-year flood event inside the banks of Lyon Creek. As a part of the design, updates were submitted to FEMA, and the floodplain is due to be drastically reduced, leaving only a few tiny areas in the flood zone. No homes will be in a flood zone.

It is a long time since the City has been able to invest in infrastructure. The six blocks of sidewalks being built under the NE 178th Street Improvements project leading to Brookside Elementary School will also have flashing signs at two marked crossings. Safe Routes to Schools, a state program, contributed to the scope of the project and also provided part of the funding. The City recognizes the value of our schools, our school children, and the existence of a state program that helps provide safe access for children walking to school. The City Council has placed multi-modal transportation on its goals. As the staff analyzes the next steps to

recommend in pedestrian connectivity, it is a "safe" bet that the walking needs radiating out from our schools and the Safe Routes programs will be part of the conversation.

Whispering Willow Park is three benefits in one to our citizens. First, it provides a flood-control berm to keep floodwaters off two properties to the south that have historically been impacted by flooding. Second, that wide berm will host a path leading to the Town Center area, thus creating a new neighborhood connector in our community; and, third, it offers a good sense of place to enjoy nature once the plantings grow in.

A final perspective is to remind our citizens that construction projects can be disruptive to normal patterns. There will be

access closures and detours.

“Citizens are encouraged to continue patronizing Town Center businesses throughout the Lyon Creek project construction.”

For one weekend in July, a complete closure of State Route 522 is planned, with traffic routed around it. Not only do we ask your

forbearance during these temporary disruptions, we ask you to help our businesses. The main retail area in Lake Forest Park will be open during construction, and counting on all of us to keep patronizing these businesses. You may have to change your route sometimes, but please don't stay away.

Whispering Willow Park Grand Opening Announced




The grand opening event for Whispering Willow Park coincides with *Kids to Parks Day* – May 16. It

Flood Reduction Efforts Continue—Construction Anticipated June - September 2015

Following the severe flood event in December 2007, the City embarked on its journey to reduce flooding in lower reaches of Lyon and McAleer Creeks. Using grants from the Federal Emergency Management Agency, King County, and a partnership with WSDOT,

the City has completed project design, and construction is anticipated for this summer. The project has been carefully designed to minimize impacts to traffic on State Route 522

while providing numerous benefits to the community including:

- Replacement of four aging culverts, removal of barriers to fish migration, and restoration of two wetlands;
- Flood protection for numerous homes, the Town Center, Northshore Fire Department station, and Bothell Way.

As construction approaches, the City will notify travelers of schedules and closures by way of message boards, website newsflashes, and future articles in this publication. City Council Holds First City Council Town Hall Meeting, Next Planned May 7

 On Thursday, February 5, the Lake Forest Park City Council hosted its first City Council town hall meeting at Lake Forest Park City Hall. An estimated 60 citizens came and discussed with Councilmembers key council initiatives, including stream restoration, transportation, strategic planning, and community vitality. The Council listened to citizens' concerns and suggestions about a wide range of issues affecting Lake Forest Park.

One citizen who attended the meeting said, "A big thank

you to all Councilmembers. Sharing your goals and objectives with the citizens of the city and listening to our concerns brings us all together."

This was the first of three City Council town hall meetings scheduled this year. One of the five Council goals established in 2014 was to "develop a strong communications program" based on "two-way communication strategies with the public." The Council subsequently formed an Ad Hoc Communications Committee to develop and implement a communications strategy. In a report to the Council in September 2014, the Communications Committee recommended quarterly City Council town hall meetings. Based on citizen feedback, the Council may increase the number of town hall meetings, if this continues to be an effective communication tool.

The City Council is currently updating its strategic goals and working with the Administration to refine and prioritize the Citywide work plan. This will provide great topics for the next town hall, which is scheduled for May 7, 2015. Additional details will be available on the City website as they become available.

McKinnon Creek Trail Update

McKinnon Creek Trail is a 40-year-old neighborhood pedestrian trail located on public right-of-way connecting NE 184th Street to the 4700 block of NE 187th Place.

Many Lake Forest Park residents use it throughout the year to both enjoy nature and link to the Town Center, and the City has planned safety improvements, such as a new layer of gravel and installation of split-rail type fencing near wetlands and streams.

In addition to serving Lake Forest Park residents, this area also includes a service road used daily by the Lake Forest Park Water District to access water facilities and another used by the City for annual utility inspections. The City is determined to balance environmental and neighborhood connectivity concerns and, this year, a third-party environmental consultant will review potential impacts and opportunities in this area. Stay tuned for more information.

Comprehensive Plan Update: Next Steps



Reflecting the community's vision and providing a blueprint for how the City will evolve over the next 20 years is the intent of the Comprehensive Plan update that is currently underway. The update provides guidance that will influence the City's capital investments and land use development. All Puget Sound jurisdictions are required by the Washington State Growth Management Act to complete a periodic update this year. The process began in spring 2014 and is scheduled for completion late this summer. The update builds on the existing Comprehensive Plan, which was adopted in 2005 and will bring the Plan into consistency with other City plans adopted since the last update (Legacy Plan, Community Forest Management Plan and Southern Gateway Sub-area Plan).

Citizen input is critical to the update process. The City has heard from many people through the community conversations that started last summer to aid in the creation of a new vision for the City. The outreach process so far includes:

- * *Community conversations* - Over 250 people participated in a series of informal, but structured, outreach activities intended to invite comments on the City's future.
- * *Phone survey* – 150 Lake Forest Park residents participated in a statistically significant survey which included questions focused on overall satisfaction with the City, key priorities for public services and funding strategies.
- * *Web page* - Lakeforestpark2035.com was developed to describe the visioning and Comprehensive Plan update purpose, process, and to

Residential Burglary Suspects Arrested

Did you know Washington state ranks highest in the nation in property crimes? While this ranking is supported by a recent increase in residential burglaries in our community, the Police Department wants residents to know that addressing this trend is a priority. In 75 percent of burglaries in town, the back or sliding glass door was broken and most of the homes did not have alarms. Of those with alarms, the alarm had not been set.

What can you do? The City website contains info about the Block Watch, Crime Watch, and Vacation Check programs; consider installing alarms; improve/increase exterior lighting; fortify/use locks on all doors/windows; and trim bushes/shrubs to make entry points more visible. Residents are also encouraged to utilize the City's Vacation Check program. Call the Police Department at 206-364-8216 for more information.

provide opportunities to participate. There were over 4,000 website visits and over 1,000 people signed up for email updates.

- * *Visioning workshop* - A public workshop was held to invite citizens to help craft the vision statement.

Concurrently, the City's Planning Commission has met twice a month since last May to guide the update by reviewing information, making recommendations on policy direction and working directly with other City commissions to develop policies in certain areas. The Commission developed a draft vision statement based on ideas and input shared during the visioning process. It is intended to reflect community direction, and is a starting point that will continue to be refined through the plan update process. Here is the Planning Commission's current draft of the statement:

What is a Vision Statement? A vision statement...

- Communicates what the City wants to be like in the next 20 years
- Provides overall "big picture" guidance for the entire Comprehensive Plan
- Is supported by the goals and policies in the Comprehensive Plan
- Is often formatted as a short paragraph

DRAFT Vision Statement: Lake Forest Park 2035

In 2035, our balanced approach to environmental preservation, economic vitality and attractive residential character has allowed Lake Forest Park to flourish. We have preserved and enhanced our natural environment and unique residential neighborhoods as defining features of our city. A vibrant Town Center is the cultural heart of our community and, together with other neighborhood centers, fosters a resilient economy and provides a diversity of shopping and entertainment opportunities that appeals to all ages.

Our neighborhoods are safe and connected to each other and to community gathering places by well-designed paths, sidewalks and bike lanes. Our legacy of collaboration with neighboring jurisdictions has inspired solutions to our regional needs and issues.

The City welcomes continued conversation. Within a couple of months, the Planning Commission will complete its review and send a draft to the City Council, followed by a public workshop for the Council to receive input on the draft. Sidewalks, Pedestrian-activated Crosswalks, and Other Non-motorized Safety Improvements Planned for the NE 178th Street Improvements Phase 2 Project

Construction of the NE 178th Street Improvements Phase 2 Project is anticipated to be underway in late May, with completion targeted for early November 2015. This approximately \$2 million project in the vicinity of Brookside Elementary School features much-needed non-motorized safety improvements, including curb, gutter and sidewalk; bicycle lane; pedestrian-activated crosswalk signals; low-impact development construction features, including permeable cement concrete sidewalks; and replacement of the McAleer Creek culvert under NE 178th Street.

Residents are advised that NE 178th Street, through the project limits, will be closed to through traffic during the construction period. Traffic will be detoured around the work zone onto NE 180th Street and 33rd Avenue NE. Access within the work zone will be provided at all times to residents, emergency services, postal and delivery services, and garbage service. Pedestrian access will also be maintained.

This project is made possible by grants from the Federal Highway Administration, Washington State Department of Transportation's Safe Routes to School program, the state Transportation Improvement Board, and the state Department of Ecology.


