Approval of Meeting Agenda:

Mr. Dee thanked the Tree Board for watering trees planted along the Burke Gilman Trail. He said that he has recently been asked why the Planning Commission is reviewing the subdivision code.

Connie Holloway

CMR. HOLLOWAY: Cmr. Holloway gave an update about local actions that had taken in opposition of the Paine Field expansion. She reported that a North-end Neighbors Noise group recently met and they will meet again on September 13, 2017 at the North City Water building. She then reminded the Commission of the Comp Plan goal EQ – 6.4. She stated that what has been proposed is for 22 planes to take off from Paine field per day, though they have been approved for more.

Mr. Saunders requested that the Commission respond to the question that Mr. Dee raised. Mr. Bennett explained that the City's current code is dated and is not in compliance with state laws.

Old Business:

Commissioners reviewed the draft chapter LFPMC 18.05, beginning at 18.05.110 (B). Minor grammatical and word choice edits were proposed and accepted by consensus. See attached draft with track changes for details of recommended code updates.

Reports/Communications/Announcements:

Ms. Semra Riddle introduced herself as the new official Liaison to City Council. She stated that her goals in attending Planning Commission meetings is to listen, get the “big picture,” and to report back to Council about where the Planning Commission is in its regulatory update process. She also committed to giving regular updates for the Big 5 Projects that are currently the focus for City Council.

Mr. Bennett described the current draft of Ordinance No. 1157, which amends the tree regulations and will be reviewed during a public hearing at the upcoming Council Meeting. He also briefed the Commission on
