Welcome and Introductions

LFP Stewardship Foundation Presentation

Jean and Mamie gave a short background on the history of the Stewardship Foundation, how it started, what projects they work on, their goals and values they strive for. An open discussion with the Parks and Recreation Advisory Board Members and the Stewardship Foundation then took place on topics like:

- What current or upcoming projects could the Board help or partner with? The Stewardship Foundation mentioned the monthly work parties at Grace Cole, Five Acres Woods funding, a failing culvert to make sure there is full fish passage, salmon release school project, McAleer Creek ravine restoration, etc.
- Where do you see LFP parks going? What would you like to see in them recreation wise? The Stewardship Foundation noted active parks is not in the mission but are not against it. Like Five Acre Woods, they would like to see some active recreation with ADA accessibility in the park along with the restoration and preservation of the woods.

The Stewardship Foundation and Board Members agreed they would like to make sure to keep an open dialogue for potential partnership in the future should a project align with both groups' goals.

60 use. Ben is putting together a presentation with pictures and potential opportunities he
61 will show at an upcoming meeting.

63 The group agreed to move the Parks and Recreation Advisory Board meetings to the
64 third Tuesday of every month rather than the third Monday.

67 work with them, not against. Rotary is another group to work with. Mentioned Budget
68 season is here and the group could present to them if they have ideas.
