### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE FOREST PARK, WASHINGTON, EXPRESSING ITS POSITION ON PROPOSITION NO. 1, PROPOSED MERGER OF NORTHSORE FIRE DEPARTMENT INTO WOODINVILLE FIRE & RESCUE**

**WHEREAS**, King County Fire Protection District No. 16 Proposition 1 proposes a merger of Northshore Fire Department into Woodinville Fire and Rescue ("Proposition 1"). Proposition 1 will be presented to the voters in the special election on April 27, 2021, with the following Ballot Title:

The Board of Fire Commissioners of Fire Protection District No. 16, King County, Washington, adopted a resolution concerning the merger of Fire Protection District No. 16 (Northshore Fire Department) into Woodinville Fire & Rescue. This proposition would merge King County Fire Protection District No. 16 (Northshore Fire Department) into Woodinville Fire & Rescue, creating one fire protection district to provide fire and emergency medical services for the areas currently served by the two districts.
