Planning Commission Recommends Changes to Accessory Dwelling Units (ADU) Regulations

Over the past few years, the City Council and staff have heard from residents that the Accessory Dwelling Unit regulations are very restrictive, including preventing the building of detached units in front or side yards, even though many of the single-family homes in LFP are built in the rear of the property.

In theory, an ADU may be created as a separate unit within an existing home (in an attic or basement), an addition to the home (a separate unit with separate entrance), or in a separate structure on the lot (also known as a detached ADU or DADU).

The Planning Commission reviewed the current regulations and surveyed the community about the issue. After thoughtful discussions at meetings over the summer and fall, the Commission has forwarded its recommendations to the Council, which began discussions at a special meeting on November 4.

The Planning Commission has made several key recommendations, including removal of the rear-yard restriction, raising the height restriction to 25 feet to allow building an apartment on top of a garage or other structure, and allowing both an ADU and a DADU on lots of one acre or more. The Council will continue discussion of the Commission's recommendations at upcoming meetings and will likely hold a public hearing on them early next year.

Deadline for Enhanced ID Extended to May 2023

The Department of Homeland Security (DHS) announced in late April that it will delay enforcing the REAL ID Act until May 3, 2023. (<https://www.dhs.gov/real-id/news/2021/04/27/dhs-announces-extension-real-id-full-enforcement-deadline>) The pandemic has significantly impacted states' ability to issue REAL ID-compliant driver's licenses and identification cards, with many driver's licensing agencies still operating at limited capacity. Many passport acceptance facilities remain closed or on limited hours as well. Passed by Congress in 2005 to strengthen security standards after 9/11, the REAL ID Act had been scheduled to take effect on October 1, 2021. When enforcement of the REAL ID Act begins, every air traveler 18 years of age or older will need a compliant form of ID to fly within the United States or access certain federal buildings, including military bases. There are many ID options, including a passport book or card, or an enhanced Washington driver license or ID card. For more information, visit the WA Department of Licensing website. LFP Sewer Late Fee Moratorium Extended Through 2021

Although the utility late fee and shut off moratorium issued by Governor Inslee in March 2020 ended on September 29, 2021, the City of Lake Forest Park extended its moratorium on late fees through the end of 2021. The City of Lake Forest Park has not assessed late fees on sewer bills since March 2020.

Beginning with the January/February 2022 sewer bill, if the bill is not paid by the due date (March 1, 2022), late fees will be assessed. The late fee assessed is 10 percent of the bimonthly sewer charges on the bill for January/February 2022.

If you want to make sure you pay your bill on time and avoid late fees, consider setting up auto-pay, available through our online payment system (<https://www.cityoflfp.com/242/Utility-Billing>). If you use an electronic check (ACH/EFT) there is no service fee. You will need to register and create a customer profile to have access to this service.



Sewer Rate Increase for 2022

Your sewer bill is made up of two parts. King County assesses a fee for the cost of the disposal of the sewage – the operation of sewage treatment plants and maintenance of the facilities. The county portion is the largest share of the bill.

In 2022, the county portion will increase from \$47.37 to \$49.27 per month; the city portion will increase from \$19.02 to \$20.16 per month for single family residences. As a result, a residential bill will increase from \$132.78 every two months to \$138.86.

Keep Fats, Oils, Grease, and Wipes Out of Our Pipes!

Wipes, paper towels, and other “unflushables” can create a sewer backup in your home and the environment, so



The label might say “flushable,” but disposable wipes and other products are clogging our sewer lines and damaging pumps and other equipment. Not only are these problems expensive to fix, they can also cause raw sewage overflows into homes, businesses and local waterways. So, think trash, not toilets!

be sure to flush only toilet paper! Fats, oils, and grease (FOG) also need to stay away from pipes and drains. FOG is commonly found in food and food ingredients (such as meat fats, lard, oils, shortening, butter, margarine, many sauces, gravies, salad dressing, and food scraps), usually from rinsing dishes and washing pots and pans. Protect your home, the sewer system, and the environment, make sure these items stay out of your pipes/drains and in the trash.

Here are some helpful reminders to keep pipes unclogged:

- Don't flush trash, including wipes, hygiene products, FOG, etc. *Even if something is labeled “flushable”, these items don't break down like toilet paper, use the trash before causing trouble in your sewer pipes!*
- Never pour FOG down sink drains or toilets.
- Use drain screens to capture food particles, and dispose of them in the garbage or a rodent-proof compost bin.
- Use “dry” clean up methods before using “wet” clean up methods for kitchenware and spills.
- Collect FOG, hair, and food waste, and dispose of them in the garbage.

Lake Forest Park Recreation Opportunities with the City of Shoreline

Do you live in Lake Forest Park and have an interest in recreation? Take advantage of recreation programs offered through the City of Shoreline. Lake Forest Park residents are eligible for a 24-hour early registration period prior to the start of each season's programs, plus an 8% discount on all program fees (not rentals) through the entire year!

This year, the City of Shoreline is separating the camp registration from the overall class registration. To receive notices of the early registration dates, sign up for reminders through the City's website, Facebook and Twitter or keep watch on the City of Shoreline's webpage.
