A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE FOREST PARK, WASHINGTON, ACCEPTING THE 28TH AVE NE CULVERT REPAIR PROJECT.

WHEREAS, the City of Lake Forest Park (City) entered into a contract for the construction of the 28th Ave NE Culvert Repair project (Project) with Chrome General Contracting, Inc. (Contractor) dated September 12, 2024; and

WHEREAS, the City has accepted the work as complete; and

WHEREAS, the City has not received any disputed claims from the Contractor for additional compensation related to extra work, changed conditions, or extended overhead;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Lake Forest Park, as follows:

Section 1. ACCEPTANCE. The City Council of the City of Lake Forest Park resolves that the City gives final acceptance of the 28th Ave NE Culvert Repair project performed under the contract with Chrome General Contracting, Inc. dated September 12, 2024, subject to all contractual warranties and that period in which liens against retainage must be filed commences as of the date of this Resolution.
