**WHEREAS**, the City of Lake Forest Park (City) entered into a contract for the construction of the 35<sup>th</sup> Ave NE Drainage Improvements project (Project) with RW Lockwood Construction, Inc. (Contractor) dated October 9, 2024; and

**WHEREAS**, the City has accepted the work as complete; and

**WHEREAS**, the City has not received any disputed claims from the Contractor for additional compensation related to extra work, changed conditions, or extended overhead;

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Lake Forest Park, as follows:

Section 1. ACCEPTANCE. The City Council of the City of Lake Forest Park resolves that the City gives final acceptance of the 35th Ave NE Drainage Improvements project performed under the contract with RW Lockwood Construction, Inc. dated October 9, 2024, subject to all contractual warranties and that period in which liens against retainage must be filed commences as of the date of this Resolution.
