A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE FOREST PARK, WASHINGTON, AUTHORIZING STAFF TO CONTRACT FOR THE PURCHASE OF FOUR ATS SPEEDALERT RADAR MESSAGE SIGN TRAILERS

WHEREAS, the Traffic Calming Group, consisting of the Police Department, Public Works, and the Traffic Engineer, recommends the purchase of four message boards that will assist the City's Traffic Calming Program; and

WHEREAS, the boards provide speed-dependent messaging and flashing LED alerts; and

WHEREAS, the four message board trailers would also benefit the public by notifying them of detours, emergencies, and community events; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Lake Forest Park, as follows:

Section 1. AUTHORIZATION. The City Council authorizes staff to contract for the purchase of four ATS SpeedAlert 24 Radar Message Sign Trailers, detailed in Attachment A incorporated herein.

Section 2. CORRECTIONS. The City Clerk is authorized to make necessary corrections to this resolution including, but not limited to, the correction of scrivener's/clerical errors, references, ordinance numbering, section/subsection numbers and any references thereto.
