

May request amendment to deliverable and/or due date. So long as the due date does not extend beyond June 15, 2025.

Preempt, supersede, and invalidate

Preemptive six months after periodic update due date:

- 2 accessory dwelling units per lot, for all urban growth areas (RCW 36.70A.680 and RCW 36.70A.681).
- Conversion of commercial buildings to multifamily (RCW 35A.21.440 or RCW 35.21.990).
- Middle housing (RCW 36.70A.636 and RCW 36.70A.635).

Preemptive December 31, 2025

- Co-living for UGAs on lots that allow 6+ dwellings (RCW 36.70A.535)

Other key due dates

Specific due date that is not the periodic update deadline

- Local Design Review [RCW 36.70A.630](#) – due six months after update
- Proportionate impact fees [RCW 82.02.060](#) – due six months after update

No specified due date. To be done with update

- Unit Lot Subdivisions [RCW 58.17.060](#) (*Amends state subdivision law; would also apply to partially planning communities*)
- Minimum Parking Requirements – Residential Development [RCW 36.70A.622](#)

Takes effect by a specified date, with retrospective date collection requirements for certain jurisdictions, and with provisions tied to periodic update after January, 1, 2026

- Local Project Review and Local Project Review Reporting Requirements for certain jurisdictions (2SSB 5290)
Various sections of RCW 36.70B amended, including [RCW 36.70B.080](#) – timeline requirements takes effect January 1, 2025 (but reporting requirement to include data from 2024), certain provisions the next update after Jan. 1, 2026.
