## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Lake Forest Park from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

## INFORMATION ABOUT THE CITY

The City of Lake Forest Park serves 13,000 citizens in King County. It is administered by a mayor-council form of government. The City has seven elected Council Members and an independently elected Mayor.

The City operates on a \$37 million biennial budget and had operating revenues of \$18.6 million in fiscal year 2016. Its 60 employees provide services including surface water, sewer, police, municipal court, public works and planning and development.
